District 19 had several changes to school utilization and one change to middle school zone lines approved over the last 2 years: The siting and co-location of new District 19 middle school (19K935) in building K667. CEC approved a rezoning proposal to creates a zone for new middle school (19K935). Including the opening of a new District 75 High School program with Maxwell High School in the K660 building.

Over the past five school years, enrollment in District 19 schools declined by over 2,400 students across grade levels K-5. In that same time period, middle and high school enrollment has increased. Since the 2018-2019 school year, district elementary enrollment in District 19 has decreased by14%, and charter elementary school enrollment has increased by about 2%. In the same time period District 19 middle school enrollment has decreased by 8%, while charter middle school enrollment has continued to grow.

There are 3 elementary schools in District 19 with enrollments of less than 250 students (PS 190, PS 213 and PS 325). The middle schools in District that have enrollments under 400 (IS 171, IS 218, IS 364, J663, M678). School of The Future (19K663) which has seen a 31% decrease over the last 5 years.

District 19 elementary schools retain more District 19 residents than schools at the middle school level. In District 19, 54% of elementary school students, 53% of middle school students, and 26% of high

school students choose to attend district schools in District 19. Seventy-five percent (75%) of elementary school students and 69% of middle school students who reside in District 19 attend school in the district.

September 2021, East New York Family Academy moved into their brand-new building.

There is a 224-seat deficit of District 75 high school seats in District 19. A new District 75 program opening in the 2021-2022 school year at Maxwell High school will provide an additional 120 seats for students who qualify for a District 75 placement.

Students with disabilities, English Language Learners, and Students in Temporary Housing:

20% of District 19 students in grades K-8 qualify for Individualized Education Programs (IEPs).

12% of District 19 ES and MS students qualify for English Language Learner (ELL) services. • District 19 has fewer students qualifying for ELL services on average than the borough and City.

District 19 serves 2,672 students in temporary housing across grades K-12. There are 20 schools in District 19 serving elementary grades where at least 10% of students live in temporary housing.
